- All registration forms must have a valid email address and a GSM telephone number.
- All applications must be received no later than 5 working days before the test.

## **ACCA CBE Registration Guidelines.**

- Application form must be submitted at least 5 days before the examination date.
- Candidates should read instructions on the registration form before completing.
- Candidates should have a valid ACCA student registration number.
- Please fill in all your details – ACCA registration number, Date of Birth, a valid email address and telephone numbers. NOTE: All sections must be completed by candidate.
- It is the responsibility of the candidate to ensure that the subjects, units, and modules they would like to take are available in the exam session they are applying for.
- All CBE examinations will be held at the British Council designated CBE site. The British Council has the right to change venues, but candidates affected will be notified before the exams are held.
- All candidates are to ensure that they bring with them valid means of identification, i.e., International Passports, Driving Licence, National ID or School ID to the examination venue. Failure to produce the above documentation shall result in the candidate being denied sitting for the examination.
- Payment of fees to the British Council is confirmation on acceptance of these terms and conditions.

- All offline payments should be made by bank transfer to Standard Chartered Bank Account 0002859402 with account name British Council Trading Services Nigeria Limited.
- Candidates must attach the evidence of payment; one passport photograph and a copy of valid ID card is to be submitted via email to **exams.repository@britishcouncil.org**
