# **Voluntary Policing Sector**

# Ve aim to:

Support Voluntary Policing Sector (VPS) groups to —

- Improve their services to all community members
- Operate in a manner that is both accountable and respectful of
- Work in close coordination with the Nigeria Police Force and other relevant counterparts to make communities more secure

# We are working to:

- · Enhance the organisational and management capacity of selected voluntary policing groups
- Strengthen their capacity to deliver the services that citizens need and want with due regard to the law
- Improve VPS engagement and accountability with local communi-
- Increase the amount of coordination between VPS groups and the Nigeria Police Force and other relevant groups in the local community
- Share examples of good practice with other VPS groups and encourage them to adopt these practices

- For many Nigerians, especially the poor, voluntary policing plays a pivotal role in addressing safety and security needs
- Nigerians are increasingly using voluntary policing to fight crime (32% of Nigerians surveyed\*)
- Nigerians are more satisfied with services provided by VPS groups (87%), than services provided by the Nigeria Police Force (55%)
- Reasons Nigerians are using VPS: (1) rise in crime, (2) delays in justice system, (3) collusion of the formal police with crimi-

## How:

- Mapping of VPS groups in selected communities
- Training in management, crime prevention and reporting, human rights and gender sensitivity
- Procedures and codes to mainstream the principle of gender aware behaviour towards women and encourage the participation of women as members of VPS groups
- A complaints system that allows for tracking of cases and accountability
- Coordination forums between the police, VPS groups and other community groups

- Participated in the distribution of operational equipment to VPS groups
- Involved in the inauguration of NPF /VPS Coordination forum
- Supported the process of simplifying the Neighbourhood Watch Law
- Provided a venue for meetings and trainings
- Improved relationship with VPS groups
- Monthly security meeting with VPS groups

# Justice for All: Making a difference

Improving services of the Voluntary Policing Sector

Profile: Member of Vigilante Group of Nigeria and a voluntary policing sector (VPS) group in Kano. She participated in trainings for VPS groups organised by the Justice for All programme.

## The story so far:

For many Nigerians, especially the poor, voluntary policing plays a pivotal role in addressing safety and security needs. The role of voluntary policing groups is to protect communities. Their work has grown over the years to complement the work of the Nigeria Police in ensuring the safety and security of the citizens. The groups are registered in some states as community development associations, neighbourhood watch groups, while some are registered with a national body known as Vigilante Group of Nigeria.

Justice for All is working with selected VPS groups in Lagos, Enugu and Kano. The programme in partnership with a local non-governmental organization, the CLEEN foundation, has provided training for these groups on organizational management, human rights, basic policing skills, service delivery, gender issues, crime scene management and conflict management. In addition, some of these groups has received basic operational equipment (rain boots, rain coats, torch lights etc.) to aid their duties.

Salamatu participated in the J4A trainings. She said, "We acquired skills in the area of intelligence gathering for the police. We were taught new techniques on handling criminal matters in the communities and evidence gathering/presentation for court proceedings."

## What happens next?

In addition to the VPS trainings, Justice For All worked to with the community to create *Community Accountability Forums* to monitor the activities of the VPS groups. These Forums are comprised of VPS groups, traditional leaders, community based organisations, representatives of religious organisations, and women and youth organisations, and meet regularly to combat safety and security issues in their communities.

## The story so far:

The Ministry of Human Capital Development and Poverty Reduction of the Enugu State Government is mandated to oversee and regulate the activities of the Neighbourhood Watch, which are voluntary policing sector groups (VPS) in the State. Justice for All is working with selected VPS groups in Enugu North, South and East Local Government areas through a collaboration with the supervising ministry.

Honourable Godwin Ogenyi stated, "Enugu is one of the safest states in Nigeria as a result of the J4A contribution in building the capacity of Neighbourhood Watch members to improve their services to community members in a manner that is both accountable and respectful of the law.

## What happens next?

As a result of an agreement between the Police Commissioner and the Commissioner of the Ministry supervising the VPS groups, plans are being developed to simplify the law establishing the Neighbourhood Watch in Enugu State, through the technical assistance of the Justice for All programme. A public awareness programme is being designed to disseminate information about the new simplified law and other key products that were developed with J4A support.
